Program description:

The Fulbright Commission Portugal and the U.S. Consulate in Ponta Delgada, Azores, would like to bring an expert U.S. speaker to Portugal to lead a one-day workshop to be held on May 8th for higher education international relations officers and administrators, towards the goal of building institutional capacity for hosting more U.S. students at public and private higher education institutions in Portugal.

With the support and guidance of the U.S. speaker, the topics to be explored during the workshop will be related to current challenges for U.S. students wanting to study abroad, challenges Portuguese HEI will face recruiting U.S. students, best practices in providing support for U.S. students on site, issues related to visas and residency permit regulations and management of expectations of both hosts and U.S. students, their parents, and their home institutions when they study abroad. There may additional programing with other Portuguese institutions or higher education stakeholders as well.

The grant covers all flights/transit, meals and incidentals and hotel. Additionally, speakers will receive a small honoraria of \$200 per each day of programming or workshops.

- Your name, title, institution, number of years of experience in the field, and information related to your any language proficiency, and contact information;
- Confirmation of your U.S. citizenship (documentation not required to express interest);
- A brief explanation (no more than 350 words) of why you are a strong candidate for this speaking opportunity, including your skills, knowledge, professional experience, regional familiarity, or other qualifications.
- An online link to your CV (optional)

The successful candidate will be put in touch directly with the primary contact overseas (at the U.S. embassy or consulate, bilateral Fulbright Commission, or a partner grantee) to discuss program details and travel grant logistics. Please note that candidates who have not yet participated in one of USA Study Abroad's Short-term Overseas Opportunities for Expert Speakers on U.S. Study Abroad are strongly encouraged to apply.
